ONLINE CHECK IN.

UNACCOMPANIED MINORS

Assistance to Unaccompanied Minors (UMs) is provided to children between 7 and 11 years of age, travelling alone and who are not accompanied by a guardian passenger aged 16 years or older.

The service is optional for any unaccompanied passengers aged between 12 and 16 years of age, travelling on their own.

UM Fees: A non-refundable / non-transferable service fee of €80 per unaccompanied minor, per segment, has to be collected at booking stage.

Note: UM's can only be booked against Public fares. Special offers, private or tour operator fares do not apply for unaccompanied minors.

SPORTS EQUIPMENT

- Sports equipment is to be packed separately.
- Sports equipment can be checked-in free of charge, if the total piece/weight falls within the passenger ticket hold baggage allowance. If it goes beyond the allowed piece/weight limit, then passenger will have to buy a sports equipment voucher.
- Each voucher is valid on a one-way trip basis which must be presented during check-in. Fee is non-refundable, non-transferable.

MUSICAL INSTRUMENTS

- One can purchase by visiting via KM Malta Airlines Sales Channels, via the Call centre on **+356 2135 6000**, or by visiting **KM Malta Airlines Sales Office** located at Malta International Airport.
- Musical instruments can be accepted as checked-in baggage, carry-on baggage or cabin-seat baggage, depending on their size and shape.
- **All musical instruments or equipment can be checked-in free of charge**, if the total piece/weight falls within the passenger ticket hold baggage allowance. If it goes beyond the allowed piece/weight limit, then passenger will have to buy an excess baggage voucher.
- Musical instruments have to be packed in a hard case.

PASSENGERS WITH REDUCED MOBILITY

- Assistance for passengers with reduced mobility who need to get from the check-in desk onto the aircraft, is provided by the airport authorities and not by the airline. Therefore, it's important that the obligatory minimum notification deadline is adhered to, as KM Malta Airlines must notify beforehand the respective airport PRM assistance department to provide this service.
- **Booking:** For passengers requiring wheelchair assistance, or any other type of mobility aid, KM Malta Airlines reservations must be informed by not later than 48 hours prior to the passenger's flight departure. Failure to advise the airline by at least 48 hours prior to the passenger's flight departure will result in delays and inconvenience for clients to be embarked and disembarked from the aircraft.
- **Up to 2 pieces of mobility equipment per person can be booked free of charge.**
- Battery powered wheelchairs require clearance for carriage from KM Medical Helpdesk at: medical@kmmaltairlines.com




PASSENGERS WITH MEDICAL NEEDS

Passengers with the following conditions require a MEDIF (medical information form), which must be submitted in advance for review and approval by the airline's medical Consultant. A fee amounting to the equivalent of €20 per MEDIF, payable by credit card applies.

- Passengers who need a stretcher or incubator on board the aircraft.
- Passengers whose medical condition requires oxygen supply on board the aircraft during the flight.
- Passengers who require extra seating to accommodate leg elevation.
- Passengers with serious sickness or injuries.
- Passengers who cannot take care of themselves on the ground or during the flight.
- Expectant mothers over/including their 36th week of pregnancy.
- Passengers who require the carriage and use of medical equipment on board the aircraft.
- Passengers whose fitness for air travel is in doubt.



MEDICAL SYRINGES

- As long as passengers carry a valid medical prescription with them, they are allowed to carry with them in the aircraft cabin their pre-filled low-molecular-weight heparin syringes (Glucagon injection, insulin, EpiPen). These items can be carried in their hand baggage, in a sealed package, as medicines are subject to screening.

PROVISION OF IN-FLIGHT OXYGEN

- For passengers requiring oxygen on KM Malta Airlines flights, since there is only a limited amount of extra oxygen supply on board, this has to be booked between 2 weeks and 48 hours prior to departure by contacting the KM Malta Airlines Medical Help Desk by email at: medical@kmmaltairlines.com. The cost of providing extra oxygen is € 115 per flight sector, and this cost must be paid in advance by credit card.

CARRIAGE OF GUIDE DOGS OR PETS

Carriage of Assistance Dogs

- Recognised Assistance Dog (Guide dogs) that meet the full membership criteria of the International Guide Dog Federation or Assistance Dog International may be carried in the aircraft cabin on KM Malta Airlines operated flights free of charge. Pets carried in the passenger cabin (PETC)

- Passengers travelling with pets in the cabin (PETC) have to make sure that the weight of the pet including the soft carrier should not exceed 10 kgs. The carrier must not exceed 40 x 34 x 18 cms in dimensions.
- A fee of **€85 per way per carrier** will be charged. Fee is non-refundable.
